
2). The Multi Storeyed Building inspection committee, Ranga Reddy District have inspected the above existing Multi Storeyed Building and recommended for the issue of renewal of No Objection Certificate for Occupancy after satisfying the Open Spaces, Means of escape, working condition of Fire Fighting equipments as per the No Objection Certificate for Occupancy and remittance of renewal fee Vide reference 4th cited above.

3). Therefore, this Office has **renewed** the No Objection Certificate for Occupancy to the existing Multi Storeyed Building of M/s. Shilparamam (Auditorium), in Sy.No.64, Madhapur Village, Serilingampally Mandal, Ranga Reddy District with Basement + Ground Floor + 01 Upper Floor + Terrace Floor with a height of 21.00 Mtrs. for Assembly Occupancy (D) Subject to the following conditions.

- i. All the Fire Fighting equipments shall be maintained in good working condition as seen during inspection.
- ii. Any loss of life or property due to non – functioning of Fire Fighting equipments and other installations shall be the responsibility of the management.
- iii. Addition /alteration, if any in the building may be obtained with prior permission from this Department.
- iv. The Departmental Officers will be inspected surprisingly, if found any deviation, deficits and non-working condition of Fire Fighting equipments will be prosecuted in the Court of law.

4). Renewal of No Objection Certificate is valid for a period of five (05) years from the date of issue of this renewal of No Objection Certificate and the management may apply for further renewal before two months from the date of expiry.
